- submit the articles (1 hard printed-out copy), signed by the author and scientific supervisor, and in electronic form on a CD or via e-mail.

Articles should be done in Word formats (.doc, .docx) and should not be longer than 5 A4 sheets, including figures, tables, diagrams, references. Instructions for the article and sample design can be downloaded from the website of the conference.

Submitted articles will be reviewed. All of the conference participants, whose articles are accepted for the conference, will be sent an e-mail invitation by **March 27, 2020**.

## CONFERENCE FEE

In order to organize, conduct a conference and prepare a collection of scientific articles, a participant must pay a conference fee for the participants from foreign countries – **9 USD** or **8 EUR**.

The conference fee must be paid by **March 31, 2020**.
