

## ARTICLE SUBMISSION

In order to participate in the online conference till **May 11<sup>th</sup>**, 2020 it is necessary:

- fill in a registration form at the <https://conf.grsu.by/konffem/ru/registratsiya>;
- submit a printed version of the signed article to the address of the organizing committee or in the electronic form (.doc, .docx) to the e-mail address of the organizing committee.

The article must be done using Word in A4 page format. The article should have a maximum length of **6 pages** of text, including figures, tables, diagrams, and a list of references. Instructions on the article design and the sample design can be downloaded from the web-site of the conference.

All of the participants whose articles are going to be accepted after the peer review will receive an e-mail invitation to the conference by **May 15, 2020**.

### ORGANIZATIONAL DUES

In order to organize, conduct a conference and prepare a collection of scientific articles, the participants must pay an arrangement fee which is for participants from foreign countries – **25 USD** or **23 EUR**.

The arrangement fee must be paid until **May 20, 2020**.
